The TCPO has been given the responsibility to review the Reform part of SAAP, monitor the progress of Reform implementation and confirm the amount of incentive to be released. The TCPO will follow up with the State Mission Directors to get the road map in the form of PERT/CPM from all States/ULBs and inform the progress of formulation of roadmaps by States/UTs week to this Ministry.
