Minutes of the 13th Meeting of Apex Committee of Atal Mission for Rejuvenation and Urban Transformation (AMRUT) held on 09.09.2016

The List of Participants is at Annexed.

At the outset Secretary (UD), Ministry of Urban Development, Govt. of India and Chairman, Apex Committee welcomed the participants. Secretary (UD) emphasized about the need for timely implementation of projects and to carry out time reforms in a time bound manner to make the public services available online and hassle free.

Joint Secretary (UD&AMRUT), Ministry of Urban Development and Mission Director briefed the Committee that SAAPs of ten States/Union Territories are listed for consideration. However, three of these have not submitted their SAAP. On a query from the representative of Uttarakhand regarding release of instalment of CA towards JnNURM projects JS(UD& AMRUT) advised the States to submit fresh Utilization Certificates in such cases(even if they have submitted earlier in 2014) and the funds will be released expeditiously. Since the window for JnNURM projects is now available for a short time only it essential that the papers are submitted urgently. He also apprised the Committee that next and final SAAP for the remaining Mission period will be taken up for consideration/approval in October/November this year. He also advised that the States could delegate powers to the State Mission Director for execution of small projects. The State MD may not wait for approval of SHPSC for small projects. He could initiate execution of the same and seek approval of SHPSC subsequently. He requested the States to make brief presentation on their SAAP and begin with Kerala.

The additional Secretary stated that the facilities like bus shelters/foot over bridges or parking should not be funded fully by the government. The state government must include PPP mode of funding in such

projects.

(iii) Secretary (UD) desired that details of total JnNURM project approved for release by the Apex Committee of AMRUT and their present status of release may be submitted on file for his perusal.

Agenda Item No 3. Approval for funding Capacity Building Programme in Singapore.

The APEX Committee considered the proposal for sanction of international passage cost of 100 Government of India officers participating in the training programme organized by the Government of Singapore. As per the MoU the Singapore Government is bearing the training costs and local hospitality. The to and fro passage to Singapore is to be borne by the Government of India. This works out to Rs 45 lakh. The proposal has been concurred in by the Internal Finance Division. The Committee approved the proposal.

Additional Agenda: Approval of SAAPs of Sikkim, Arunachal Pradesh and Delhi

The National Mission Director brought to the notice that after the approval of the SAAPs today, the SAAPs of Sikkim, Arunachal Pradesh and Delhi are left for approval for the year 2016 – 17 which involve a total of 6 Mission cities. The National

Mission Director proposed that the Committee may authorize the Chairman of the Apex Committee to approve the SAAPs and the same may be placed before the Apex Committee in its next meeting. The Committee approved the proposal.

General Remarks

The Director (HUPA) stated that as part of convergence process, the AMRUT projects should also provide infrastructure eligible under AMRUT for projects under Pradhan Mantri Awaas Yogna(PMAY). Where these are situated outside the Municipal Limits the same could be extended up to the border of the Municipality.

Dr. P Babu Economic Officer, NITI Aayog, gave a brief analysis of the Mission stating that only 1% of the contracts have been awarded so far. This was discussed. JS(UD) & National Mission Director pointed out that the data on which the analysis is based appeared to be old and the Mission has since made substantial progress. AS(SC) advised that the Director(AMRUT) may make available the latest data to Dr. Babu and the latter may make a presentation in the next meeting of the APEX Committee. The matter may then be discussed meaningfully.

Common Conditions for all SAAPs:

i. The State/UT Govts. shall, in respect of each project, explore the possibility of funding through PPP mode, annuity based funding as well as utilising the funds available to the ULBs through State Finance Commission and 14th Finance Commission. An analysis of such options in respect of each project shall be presented by the Mission Directorate before the SHPSC at the time of seeking approval for projects.

In case the funding in a project through these sources has not been tied up, the SHPSC should satisfy itself about the reasons for the same.

- ii. The State/UT Govts shall ensure that the works are executed through the ULBs. In case the works are to executed through para-statal agencies, the process and conditions specified in the Mission Guidelines in this regard shall be strictly followed.
- iii. State Govts. needs to clearly indicate about the availability of Land and other clearances. No projects should be approved by State Level Technical Committee (SLTC) which do not have land available and no work order should be issued till receipt of all clearances from all concerned departments/authorities.
- iv. Re-cycling/re-use of waste water and reduction of NRW should be given focus while approving DPRs.
- v. The State Govts. should ensure convergence between the AMRUT, Smart Cities, SBM, other related Schemes and Externally aided projects according to Mission Guidelines.

vi. Estimates in the SAAP should be based on prevailing official schedule of rates and not on market rates.

vii. Implementation of reforms will make States/UTs eligible for annual incentive. In order to get incentives reforms should be broken up into activities with timelines and sent to TCPO by the State Mission Director.

viii. The approvals towards Urban Mobility shall not be used for procurement of buses.

ix. No incomplete JnNURM projects should be taken up in AMRUT and the SLTC will ensure adherence to the Guidelines.

x. In case, the appraised cost of projects in previous SAAP exceeds the approved SAAP size for the year, the SAAP may be limited to approved SAAP size by removing some projects. Such projects may either be taken up in the next of SAAP or taken up by the State Govt. through convergence with other schemes or borne by the State/UT Government.

xi. States/UTs must ensure that there is no duplicity of projects/work and projects/item of works already approved under previous SAAP is not form the part of SAAP again.
