Minutes of the 11th Meeting of Apex Committee of Atal Mission for Rejuvenation and Urban Transformation (AMRUT) held on 8.7.2016.

The List of participants is at Annex- I

Secretary (UD), Ministry of Urban Development, Govt. of India and Chairman, Apex Committee welcomed the participants and stressed upon the importance to achieve the objectives of the Mission. He further suggested the States/UTs on following lines:

- i. States/UTs should explore possibility of PPP in every projects under AMRUT. State Committee (SHPSC) must examine and promote using PPP methodology for all water and sewerage/septage projects.
- ii. Due priority of Septage Management over underground sewerage system should be given as they are cost effective, easy to operate and maintain and can help effectively address the problem until a comprehensive sewerage network fo the entire city is put in place. He also apprised the States/UTs that expert teams from Ministry of Urban Development will assist/help them to explore this.
- iii. Entire Mission period allocation has been communicated to the States/UTs and State Governments have been requested to prepare and submit SAAP for balance allocation as early as possible, but before 31st October, 2016.
- iv. Special attention need to be given to water recycling and faecal sludge management designing the projects under sewerage sector against the approved SAAPs.
- v. The Ministry has issued detailed Guidelines for constituting A District Level Advisory and Monitoring Committee. The States/UTs should constitute the Committees at the district level in accordance with the Guidelines. The Committee will review and advise for all MoUD and MoHUPA Schemes and Missions (except Smart Cities) as listed in the guidelines.
- vi. To increase revenue resources States/UTs should explore ways to earn revenue from sale of treated waste water from STPs. For such water, power plants/Industrial zones are potential buyers. Enabling policy regarding use of treated wastewater by the power plants have already been issued by the Ministry of Power. This policy makes it attractive for power plants utilise treated wastewater by permitting them to pass through the cost of such water.
- vii. State/UT should give utmost priority to timely implementation of AMRUT Projects so that benefit could reach the citizens in time and effective manner.
- viii. State/UT should also carry out credit rating to all Mission cities. The agency conducting credit rating will also advise them on base means improve the credit rating. This will help the financial stronger cities access funds from financial institutions for taking up projects. On the other hand, the weaker cities will be able to find way forward to improve their rating.

The National Mission Director informed the Committee that there is only one agenda i.e. to consider SAAP of 10 participating States/UTs and invited the officers from the participating States to make their presentation on their SAAPs starting from Tamil Nadu which will be followed by NIUA and TCPO views on their respective domain and views of Members of the Committee.

The State Govt. has also requested to allow expenditure on Parks more than 2.5% of the SAAP Size.

TCPO observed that the State has submitted the reform claims for 2015-16. In respect 2016-17 reforms the State has accomplished two reforms and rest are under progress.

National Mission Director pointed out that PDMC charges can only be shown against A&OE expenditure and expenditure on parks cannot be more than 2.5% of total SAAP Size.

In some cases 100% coverage has not been shown. State Govt. should endeavour to achieve 100% coverage in water supply and sewerage in all Mission cities.

TCPO observed that there is some inconsistency in data furnished by the State Govt. and they need to reconcile it with updated status of reforms.

Mission Director observed that proposed investment during Mission's plan period should be in accordance with total central fund allocation for Mission period communicated to the States. State Govt. should clearly indicate the source of resources to implement the AMRUT Projects.

It was observed that the State government has opposed large number of projects with higher costs and smaller cost has been proposed to be funded in the SAAP. The Mission Director desired to know whether this is leading to incomplete projects. The secretary, government of West Bengal responded that except for 2 projects where additional Rs. 150 crores will be required in 2nd phase, all other projects will be complete with the funding proposed in the plan and that additional funds will be required in the respective cities to take up additional activities which are not tagged with the activity proposed in the current SAAP.

Mission Director observed that the UT administration has proposed to construct rain water tank for the purpose of water supply which is admissible under clause: Special water supply arrangement for difficult/coastal cities etc. He further informed the Lakshadweep representative that construction of public toilet is not admissible under the Mission and advise the UT representative to allocate the proposed amount for construction of toilets to water supply sector. UT representative agreed to it.

Chairperson:

The State Annual Action Plan was approved subject to above comments and observations and common conditions mentioned by the National Mission Director and recorded later in the Minutes.

Common Conditions for all SAAPs

- i. The State/UT Govts. shall, in respect of each project, explore the possibility of funding through PPP mode, annuity based funding as well as utilising the funds available to the ULBs through State Finance Commission and 14th Finance Commission. An analysis of such options in respect of each project shall be presented by the Mission Directorate before the SHPSC at the time of seeking approval for projects.
 - In case the funding in a project through these sources has not been tied up, the SHPSC should satisfy itself about the reasons for the same.
- ii. The State/UT Govts shall ensure that the works are executed through the ULBs. In case the works are to executed through para-statal agencies, the process and conditions specified in the Mission Guidelines in this regard shall be strictly followed.
- iii. State Govts. needs to clearly indicate about the availability of Land and other clearances. No projects should be approved by State Level Technical Committee (SLTC) which do not have land available and no work order should be issued till receipt of all clearances from all concerned departments/authorities.
- iv. Re-cycling/re-use of waste water and reduction of NRW should be given focus while approving DPRs.
- v. The State Govts. should ensure convergence between the AMRUT, Smart Cities, SBM, other related Schemes and Externally aided projects according to Mission Guidelines.
- vi. Estimates in the SAAP should be based on prevailing official schedule of rates and not on market rates.
- vii. Implementation of reforms will make States/UTs eligible for annual incentive. In order to get incentives reforms should be broken up into activities with timelines and sent to TCPO by the State Mission Director.
- viii. The approvals towards Urban Mobility shall not be used for procurement of buses.
- ix. No incomplete JnNURM projects should be taken up in AMRUT and the SLTC will ensure adherence to the Guidelines.
- x. In case, the appraised cost of projects in previous SAAP exceeds the approved SAAP size for the year, the SAAP may be limited to approved SAAP size by removing some projects. Such projects may either be taken up in the next of SAAP or taken up by the State Govt. through convergence with other schemes or borne by the State/UT Government.
- xi. States/UTs must ensure that there is no duplicity of projects/work and projects/item of works already approved under previous SAAP is not form the part of SAAP again.
