Subject:-Release of Rs. 26,00,00,000/- (Rupees Twenty Six Crore only) as reform incentive to Pune Municipal Corporation (PMC) for issuance of Municipal Bonds of Rs. 200 crores under Atal Mission for Rejuvenation and Urban Transformation (AMRUT) for the financial year 2018-19.

Sir/Madam,

I am directed to convey the sanction of the Competent Authority for release of an amount of Rs 26,00,00,000/- (Rupees Twenty Six Crore only) to Pune Municipal Corporation (PMC), Maharashtra. This amount is being released as incentive for issuance of Municipal Bonds for Rs. 200 crores for financial year 2018-19 under AMRUT.

2. The aforesaid release will be governed in terms of the following principles/conditions:

- (i) The incentive fund is an additionality and no matching funds will be required to be given by the State/ULB.
- (ii) The full incentive amount will be paid in one lump sum and will be credited in the escrow account opened by the concerned ULB for this purpose.
- (iii) This release will be governed in terms of provisions of GFR.

3. No Utilization Certificate is pending at this stage in respect of above incentive.

4. The expenditure involved is debitable to the Major Head 3601-Grant-in-aid to State Government, 06- Centrally Sponsored scheme, 06.101-Central Assistance/share, 24-Urban Rejuvenation Mission- 500 Habitations, 24.01.31 Grant-in-aid General under grant No. 56 (Plan) -Ministry of Housing and Urban Affairs in the Financial Year 2018-19.

5. The amount of Rs.26,00,00,000/- will be credited to the State Governments account to RBI as per procedure laid down by Ministry of Finance, Department Expenditure vide O.M. No. F-II (45/76/SC) dated 22.02.1977.
