Subject: Revised sanction order amounting to Rs. 95,65,10,000/- in continuation of order no. K-16015/06/2016/AMRUT-II dated 29.06.2016 for release of Central Assistance (CA) (Replenishment towards adjustment of funds released as 1<sup>st</sup> instalment of CA against eligible projects of JnNURM) to Government of Rajasthan under Atal Mission for Rejuvenation and Urban Transformation (AMRUT).

Sir,

In continuation of this Ministry's sanction order No. K-16015/06/2016/AMRUT-II dated 29.06.2016 and corrigendum of even no. dated 22.03.2018 (copies enclosed), I am directed to convey the sanction of the competent authority for the release of an amount of Rs. 95,65,10,000/- (Rupees Ninety-Five Crore Sixty-Five Lakh and Ten Thousand only) to Government of Rajasthan. This amount is being released as additional fund for replenishment of 1<sup>st</sup> instalment of CA against SAAP-II under AMRUT towards adjustment of funds released against eligible project of JnNURM.

2. The total size of approved State Annual Action Plan (SAAP) -II of Rajasthan is Rs. 1072.80 Crore for 2016-17, out of which Rs. 526.11 Crore is the approved Central Assistance. The 1<sup>st</sup> instalment of 20% of the approved Central Assistance towards implementation of projects related to Water Supply, Sewerage & Septage Management, Drainage and Parks/Green Spaces approved in SAAP-II has been released. Any excess or shortfall in the first instalments shall be adjusted while releasing the second/third instalment of Central Assistance based on approved cost.

3. Diversion of Central Grants for purposes other than the Mission projects is not allowed and shall entail levy of penal interest on the amount and any other action by the Apex Committee and may include adverse effect on release of grants.

4. As per the Mission's Guidelines, State Government is required to release the Central Assistance funds along with State share to the account of State Mission Director within one month of release of Central share by the Ministry. Otherwise, interest at the rate specified by the Ministry of Finance shall be levied on the State for delay and appropriate deductions shall be made from future instalments.

5. This release will be governed in terms of provisions of GFR. The amount of Central Assistance should be kept in separate account and be open to inspection/Audit as per provisions.



6. State Government may take necessary action in respect of observations/comments made by Apex Committee and recorded in the Minutes of the 9<sup>th</sup> meeting of Apex Committee.

7. This is for replenishment of first instalment against SAAP-II and no utilization certificate (UC) is required.

8. The sanction has been entered at Sl. No. 51 of the appropriate head in the sanction register maintained in AMRUT-1B section for FY 2017-18.

9. The expenditure involved is debitible to the Major Head 3601 – Grant in Aid to State Govts, 06 - Centrally Sponsored Plan Scheme, 101- Central Assistance/Share, 24-Urban Rejuvenation Mission- 500 Habitations (AMRUT), 24.01.35-Grants for creation of capital assets under grant No. 97 -Ministry of Urban Development of the year 2017-18 (Plan).

10. The amount of Rs. 95,65,10,000/- will be credited to the State Government's account to RBI as per procedure laid down by Ministry of Finance, Department Expenditure vide OM No. F-II(45/76/SC) dated 22.02.1977.

11. This issues with the concurrence of Integrated Finance Division vide file no. E-3077260 dated 22.03.2018.

Subject: Release of first instalment of Central Assistance (CA) amounting Rs.105,22,00,000/- (20% of the approved Central Share towards project fund of Rs.526.11 crore) to Govt. of Rajasthan under Atal Mission for Rejuvenation and Urban Transformation (AMRUT) .

I am directed to convey the sanction of the Competent Authority for the release of an amount of Rs 105,22,00,000/- (Rupees One Hundred Five Crore and Twenty Two Lakh only) to the State Government of Rajasthan. This amount is being released as 1<sup>st</sup> instalment being 20% of the approved Central Assistance towards project fund of Rs.526.11 crore under Atal Mission for Rejuvenation and Urban Transformation (AMRUT) for implementation of projects related to Water Supply, Sewerage, Drainage and Parks approved in SAAP 2016-17. The total approved size of State Annual Action Plan (SAAP) of Rajasthan is Rs.1072.80 crore for 2016-17.


2. The first instalment is being released on the basis of estimated project cost and any excess or shortfall in the first instalment shall be adjusted while releasing the second instalment of Central Assistance based on approved cost.

3. Diversion of Central Grants for purposes other than the Mission projects is not allowed and shall entail levy of penal interest on the amount and any other action by the Apex Committee and may include adverse effect on release of grants.

4. As per the provision of the Mission's Guidelines State Government is required to release the Central Assistance funds along with State share to the ULBs within seven working days of release of Central share by the Ministry otherwise interest at the rate specified by the Ministry of Finance shall be levied on the State for delay and appropriate deductions made from future instalments.

5. This release will be governed in terms of provisions of GFR. The amount of Central Assistance should be kept in separate account and be open to inspection/Audit as per provisions.

6. State Govt may take necessary action in respect of observations/ comments made by Apex Committee and recorded in the Minutes of 9<sup>th</sup> meeting of Apex Committee.

7. Atal Mission for Rejuvenation and Urban Transformation (AMRUT) is a new Mission and presently no utilization certificate is pending from the State under the Mission.

8. The sanction has been enter at SI.No. 2 of the sanction register.

9. The expenditure involved is debitable to the Major Head 3601 - Urban Development, 04 - grants for Centrally Sponsored Plan Scheme, 315- Other Urban Development Scheme- Assistance to Local Bodies, Corporations, Urban Development Authorities, Town Improvement Boards etc., 04 Urban Rejuvenation Mission- 500 Habitations, 04.00.35-Grants for creation of capital assets under grant No. 95 -Ministry of Urban Development of the year 2016-17 (Plan).

10. The amount of Rs.105,22,00,000/- will be credited to the State Government's account to RBI as per procedure laid down by Ministry of Finance, Department Expenditure vide OM No.F-II (45/76/SC) dated 22.02.1977.

Sir,

I am directed to refer to this Ministry's sanction order no. K-16015/06/2016/AMRUT-II dated 29.06.2016 (copy attached) and to convey that the amount of Rs. 105,22,00,000/- released as 1<sup>st</sup> instalment of CA against SAAP-II for implementation of projects under AMRUT may be read as under:

2. The Ministry has already issued corrigendum and revised sanction order amounting to Rs. 8.9784 crore on 15.03.2018 against Ramgarh Sekhawati sewerage project of erstwhile JnNURM. The above mentioned adjustment towards the attached list of JnNURM projects is a one-time special measure and excluding the Ramgarh Sekhawati sewerage project. Thereafter, no future Central Assistance will be released against these projects.

3. The amount adjusted from funds earmarked for AMRUT against eligible project of JnNURM will be replenished and revised sanction order will be issued separately.

4. This release will be governed in terms of provisions of GFR. The amount of Central Assistance should be kept in separate accounts and be open to inspection/Audit as per provisions.



5. State Government may ensure that any amount on account of interest accrued on the Central Assistance released against these projects shall be remitted by the State to the relevant head of accounts of the Government of India in accordance with Ministry of Finance OM No:59(4) PF-I/2006(Pt) dated 28th January, 2013. In case, the interest accrued is not remitted as above, the same shall be adjusted against the fresh projects or ongoing projects of the State as per MoF OM No.59(5) PF-I/2010 dated 21<sup>st</sup> September,2011.

6. State Government may ensure that funds are actually utilized for the purpose for which it has been released and Utilization Certificate may be furnished within six months.

7. This issues with the concurrence of IFD dated 28.02.2018 vide file no. E-3077260 and with the approval of the competent authority.
