Sir,

In continuation of this Ministry's sanction letter of even number dated 29.06.2016 (copy enclosed), I am directed to convey the sanction for release of an amount of Rs 3,60,00,000/- (Rupees Three Crore and Sixty Lakhs only) to the UT Government of Chandigarh. This amount being 1<sup>st</sup> instalment i.e. 20% of the approved as Central Assistance towards project fund of Rs.18.00 Crore under Atal Mission for Rejuvenation and Urban Transformation (AMRUT) for implementation of projects related to Water Supply, Sewerage and Parks/Green spaces. The total approved size of State Annual Action Plan (SAAP) of Chandigarh is Rs.18.00 Crore for 2016-17. The administrative approval in term of Ministry of Finance's O.M. dated 31.01.2011 was conveyed vide sanction of even number dated 29.06.2016.

2. Against the aforesaid administrative approval, O/o the AG(A&E), UT Chandigarh, vide their letter No. A/C Cell/UT/CH/Urban Dev/12/16/101-Civil Suspense/16-17/844 dated 27.01.2017 (original copies enclosed) has now submitted their claim for adjustment of the amount of Rs 3,60,00,000/- (Rupees Three Crore and Sixty Lakhs only).

3. The aforesaid payment is adjustable/debit able in the accounts of the Central Government in the books under Demand No. 95 for 2016-17. The details of head are as under:

The expenditure involved is debit able to the Major Head 2217 - Urban Development, 05 - Other Urban Development Schemes, 191-Assistance to Municipal Corporations, 16-Urban Rejuvenation Mission- 500 Habitations, 16.01.35-Grants for creation of capital assets under grant No. 95 -Ministry of Urban Development of the year 2016-17 (Plan).


4. The Cheque may be issued in favour of Accountant General (A&E) UT Chandigarh.

I am directed to convey the administrative approval of the Competent Authority for the release of an amount of Rs 3,60,00,000/- (Rupees Three Crore and Sixty Lakh only) to the UT Government of Chandigarh. This amount is being released as 1<sup>st</sup> instalment i.e. 20% of the approved as Central Assistance towards project fund of Rs.18.00 crore under Atal Mission for Rejuvenation and Urban Transformation (AMRUT) for implementation of projects related to Water Supply and Parks approved in SAAP 2016-17. The total approved size of State Annual Action Plan (SAAP) of Chandigarh is Rs.18.00 crore for 2016-17.

2. In terms of Ministry of Finance's OM No. 1(8)(1)/TA/2010/31 dated 31.01.2011, based on the administrative approval, the concerned AG may classify the transaction as debit to the Major Head "8658- Suspense A/c- PAO Suspense-Transactions adjustable by the....." and claim reimbursement from PAO of the Ministry of Urban Development and clear the suspense head on realization of the cheque.

3. The aforesaid administrative approval is subject to the following conditions:

- (i) The administrative approval shall be regulated in accordance with the provisions of GFR, 2005/AMRUT guidelines.
- (ii) The Union Territory of Chandigarh would maintain a separate account in respect of AMRUT.
- (iii) The money will be utilized for the purpose for which approval has been given.
- (iv) The Union Territory of Chandigarh will furnish utilization certificate in respect of funds released at an early date in the prescribed Performa as provided in the AMRUT guidelines.

4. UT Govt may take necessary action in respect of observations/ comments made by Apex Committee and recorded in the Minutes of 10<sup>th</sup> meeting of Apex Committee.

5. The reimbursement claim of UT of Chandigarh will be adjusted by PAO, Ministry of Urban Development from the Major Head 2217-Urban Development, 05-Other Urban Development Schemes, 191-Assistance to Municipal Corporation, 16-Urban Rejuvenation Mission-500 Habitations, 16.01.35-Grants for creation of capital assets under Grant No. 95-Ministry of Urban Development of the year 2016-17 (Plan).

6. This is the first release to Union Territory of Chandigarh under AMRUT guidelines. As such, no Utilization Certificate is pending in respect of the Union Territory of Chandigarh as per requirement.

7. This issues with the concurrence of Integrated Finance Division vide their Dy. No. 1207/IFD/2016 dated 28.06.2016.

8. The Sanction has been registered at S.No. 02 of the Sanction register of AMRUT Division for the year 2016-17.


